# Method

- Conducted survey between 21 August to 24 September, 2014;
- Includes:
  - $\circ$  Letter drop to businesses and residents within the vicinity of survey area;
  - o Invitiation to stakeholders
  - o Survey/ Interviews on Broadway Ave and the Plaza Shopping Mall
- Received 121 respondents from Palmerston North;
- 64 out of 98 that answered this question cycle at least occasionally (at least a couple of times per month).



# 1. Cycle Lane Marking Options


- The plain M2-3 marking is understood by the majority of respondents.
  - Two in three (69%) think that it means 'cars cannot drive in this lane'.
  - $\circ~$  67% think that it means that 'cars cannot park over this marking'.
  - $\circ~~73\%$  consider this a good or very good way to clearly cycle lanes.
- The **M2-3 marking with green background** scored higher for understanding than other markings.
  - $\circ~$  Two in three (69%) think that it means 'cars cannot drive in this lane'.
  - A significantly higher number of responsents (78%) think that it means that 'cars cannot park over this marking'.
  - 84% consider this a good or very good way to clearly cycle lanes.
- The **M2-3 marking with the word LANE** scored slightly higher than the marking without the word.
  - o 78% think that it means 'cars cannot drive in this lane'.
  - Similarly 70% think that it means that 'cars cannot park over this marking'.
  - Four out of five of respondents (80%) consider this a good or very good way to clearly cycle lanes.







## 2. Sharrows


- Sharrows in Midblock
  - Four in five (78%) think that the Sharrow markings meant that bikes and cars should share the road.
  - One in two (49%) consider Sharrows to be a good treatment where road width is not wide enough for a cycle lane.
  - One in three (33%) consider Sharrows to improve safety of cyclists.
  - Two in five (42%) of the respondents consider that motorists will look for cyclists when they see this marking
    - Note, there was no additional information provided, results would change with education.
- Sharrows at the approach to a roundabout (intersection)
  - Four in five 80% think that the Sharrow markings meant that bikes and cars should share the road.
  - One in two (51%) consider Sharrows to be a good way to mark intersections, or that they would improve safety.
  - o 37% of the respondents consider Sharrows to improve safety of cyclists.
  - Less than half (47%) of the respondents consider that motorists will look for cyclists when they see this marking
    - Note, there was no additional information provided, results would change with education.
- Positioning of Cyclists
  - Majority of the respondents (76%) considers that the location of Sharrow markings does not indicate where cyclists should ride on the road.




#### Q2.7: What do you think this marking means?






