## 1. NZTA's Research Programme

#### Regarding sector research the GPS 2012:

- provides a mid point of \$4m per annum for NZTA to invest in research
- defines sector research as 'activities related to managing and delivering research into land transport issues'
- expectation that sector research will shape policy and implementation to achieve value for money






#### Definition of NZTA Research

#### The NZTA invests in research:

- to acquire new knowledge or better utilise existing knowledge
- that can be applied by transport decision-makers to deliver more effective, efficient and economic transport solutions



for issues prioritised by the NZTA to give effect to the Government policy statement on land transport funding (GPS)



#### Recent review of research activity class

#### The review:

- ensured research investment decisions align with NZTA's strategic direction and its IRS
- signaled a fundamental change in the way the NZTA manages research
- shifted the focus towards directed research





## Recent review of research activity class (cont)

#### With the shift towards directed research:

- research is now more top down and for transport decision maker (TDM) purposes
- TDMs are NZTA, MoT and AOs
- selected sector organisations are asked to submit challenges which research can assist to address





#### NZTA's Research Programme Framework

The review resulted in a new Framework which provides for investment in 5 research areas:

- 1. Improved access
- 2. more efficient and reliable networks
- 3. better integrated transport and land use
- 4. improved transport safety
- 5. improved environmental and social well-being

## Achievements over last year

- Sector research activity class review implemented
- 132 Active research projects managed
- 40 Research reports published
- 12 Transitional research projects contracted
- 5 NZTA Research newsletters published



## 2011/12 Research Programme

#### 23 topics approved and currently being procured:

- 4 public transport
- 3 freight
- 1 network optimisation
- 5 asset management
- 6 safety
- 2 performance monitoring
- 2 economic analysis

# 2. Evaluation of the value of NZTA's Research Programme


#### Key objective -

Assess how valuable the findings of NZTA research reports, published from 2005 to 2009, are for end users

#### Secondary objectives -

- Identify barriers and enablers to successful uptake and use
- Recommend improvements for the dissemination and promotion of research findings





#### Key results of the evaluation

NZTA research is of substantial value to end users in all areas of the transport sector although more use is at the conceptual end of the 'use' continuum:

- ✓ 100% of respondents learnt something new from NZTA's research
- √ 71% of respondents used the research to inform new or existing policies, programmes or further research
- √ 67% of respondents used the research to develop/improve standards, guidelines and specifications



#### Key results of the evaluation (cont)

- less evidence of its use in policy and programme decision making
- 'use' needs to be planned into the whole research process and beyond
- ✓ NZTA research is highly regarded because it provides practical, innovative NZ-based solutions
- active promotion and implementation of findings is a collective responsibility
- NZTA's website is not considered user friendly

- working to give more prominence to the Research Programme on its website
- Requiring promotion to be planned as part of research proposals
