	Agreed these actions in these key result areas form the work-plan for 2011-2012. (Nicci/Ted)	Wayne
	Agreed ensuring research and best practice inform policy will rely on compiling and condensing the available information to present to policy makers as much as on maintaining and building relationships, and this will rely on reviewing research and reference documents.	
	<u>Agreed</u> promulgation and dissemination must continue to rely on the RCA Forum web-site, but must investigate alternative means of communicating with planners and non-road asset managers in territorial authorities and with regional councils, possibly by compiling a suite of guidance materials onto a CD and distributing it.	
	<u>Agreed</u> the goal of the group remains to encourage and promote practical solutions to stormwater management, by coordinating stormwater knowledge and making it available to practitioners. Promulgation and dissemination of guidance on current best practice is the group's principal key result area. Ensuring research and best practice inform policy is the second key result area. Reviewing research, reference documents and policies to ensure appropriate and effective outputs for stormwater management is the third key result area.	
3. Work-plan for next twelve months	Noted the current terms of reference for the group are nearing completion of their three-year term. Agreed to adopt terms of reference for one further year.	
	Agreed the minutes were a true and proper record of the meeting. (Dale/Jon)	
	<u>Noted</u> acceptance of abstracts for the WaterNZ conference had already closed and the abstract submitted for the NZPI conference was not accepted, but Hayden and Craig have reported good progress in developing better guidance for practitioners.	

	Noted the feedback from the peer review of the three sections of the draft FAQ pages had identified numerous concerns about the style and content, including errors in the text and insufficient use of recent and local research.	
	<u>Agreed</u> the FAQ pages will not be referred back to Anguillid Consulting Engineers and Scientists and will be revised, edited and circulated for input by the group to provide a more accessible and useful reference tool. (Balt/Dale)	Wayne
