



- * Identifying and providing the assets needed by an aging population
- * Regional peer bands to reflect the wide differences in climate, rainfall, geology and topography across NZ
- * Optimal local mixtures of aggregate for local conditions
- * Readily-comparable condition-assessment parameters for unsealed roads
- * Promoting adequate investment in rural roading infrastructure to meet the economic potential and growth strategy of primary industries
- * Optimal rural road sign reflectivity
