KEY MESSAGES

To help with the planning process for upcoming RCA forums, a short survey that asked forum members to indicate their level of interest for nine different topic areas (and 53 proposed individual topics) was sent to all forum members (identified by RCAF).

Forum members were also asked to identify their preferred mode of delivery for future forums and identify any other topics they would like to see included in future RCA forums.

The survey was completed by a self-selected sample of 67 forum members.

Section 2

RESEARCH METHOD

Research Context

The Road Controlling Authorities Forum (New Zealand) Incorporated (RCAF) was established in 1996. The organisation is a closed, non-political incorporated society of road asset managers and roading professionals from all local, territorial authorities (except the Chatham Islands Council), the Department of Conservation (Te Papa Atawhai) and the New Zealand Transport Agency (Waka Kotahi).

The purpose of the RCAF is to exchange information and provide updates on sector working group activities, proposed legislation, new standards and guidelines, highway and procurement strategies and other issues relevant to road controlling authorities and the other member organisations.

The RCA Forums (run as three one-day face-to-face forums per year¹) enable members to exchange information and provide updates:

- on sector working group activities,
- proposed legislation,
- new standards and guidelines,
- highway and procurement strategies, and
- other issues relevant to road controlling authorities and the other member organisations.

To help plan the 2021 forums, the RCA Executive was interested in finding out from members their interest in topics they could bundle together for future webinars and (or) forums. This report details the findings from research designed to provide the level of interest for the following topic areas:

- 1. Roading Efficiency Group
- 2. Waka Kotahi
- 3. KiwiRail
- 4. Planning for People
- 5. Post COVID-19 Topics
- 6. Alternative Mode Topics
- 7. Operating Environment
- 8. Health and Safety
- 9. Speed Setting Rules

Research Design

Research First was engaged in running this survey to enable forum members to answer confidentially to avoid any perceived biases.

A quantitative survey consultation process was designed to ensure engagement with all forum members.

The survey was sent out to a list of members provided by RCAF (n=578). An email invitation was followed by two reminders over three weeks, from 17 March to 9 April 2021.

A total of 67 respondents completed the survey, with an average completion time of nine minutes. The response rate was 11.6 percent.


LIKELIHOOD OF ATTENDING RCA FORUMS

Members were asked about their likelihood of attending future forums via different modes of delivery.

Attending webinars was the most popular delivery mode indicated by over half of the respondents (n=36 of 67) and is likely to provide the most effective mode of delivery in the future. Note: this finding may have been influenced by webinars' seminars over the COVID-19 pandemic period, where members may have become more comfortable with this mode of delivery.

Face-to-face forum meetings at Wellington Airport or Wellington City Central received equal interest levels, similar to the interest garnered for meetings overall.

Section 4

SUMMARY OF INTEREST FOR FORUM TOPIC AREAS

When the level of interest was averaged by forum topic area, Speed Setting Rules, Operating Environment, and Planning for People were ranked as the topic areas with the highest interest levels.

But Post COVID-19 topics and KiwiRail showed low levels of interest.

FORUM TOPICS IN DETAIL


Roading Efficiency Group

Members were asked their level of interest for nine groupings of seminars. The first grouping asked about Roading Efficiency Group seminar topics.

Collaboration between RCA members, such as sharing best practice, was the topic that received the highest level of interest (42 of 67 respondents), followed by Procurement (n=38 respondents) and One Network Framework (n=35).

Asset Management Data Standards received the most polarised responses regarding levels of interest.

When considering high-interest levels, Roading Efficiency Group forum topics were ranked fourth (from nine) topic areas.



Compared to all the other topic areas, KiwiRail received the lowest interest levels among forum member respondents, particularly Interisland Ferries and their strategic opportunities and passenger rail.

But safety issues such as cycleways in the rail corridor and vehicle crossing funding received the highest interest levels in this group of forum topics.





Post COVID-19 Topics

Forum members showed less interest in post-COVID-19 topic areas when compared to all other topics, apart from KiwiRail.

In more detail, coping with long term impacts on workloads received the highest level of interest (n=21 from 67 respondents). However, the levels of interest were similar for most of the remaining topics. But the physical impacts on health received the lowest level of interest.

Figure 5-6 Average levels of interest for Alternative Mode forum topics (n=67)





The Operating Environment topic area received high levels of interest from forum members, particularly Increasing Maintenance, Operations and Capital Costs (91 percent high and medium levels of interest).

Interest was lowest for Public Transport operating model and innovation in this topic series.

Figure 5-9 Average levels of interest for Speed Setting Rule forum topics (n=67)



Other Topics of Interest

All forum members were asked to comment if they could identify any other topics they would like to have included in future RCA Forums. Nineteen members offered suggestions as follow:

- More on the Road to Zero Strategy how it's tracking, initiatives in place, Safe Network Programme progress. Low-cost low risk engineering measures, the role of road maintenance in road safety outcomes, Speed management plans - engineering up options. Funding available for road safety initiatives.
- Would be good to hear the voice of the supply chain and how they are placed to meet the needs of future infrastructure.
- Influencing GPS. Rural Provincial vs Metropolitan competition for funding
- Practical topics around network management and performance. Effective and appropriate data capture. Implementation of national strategies i.e., around speed and effective
- Urban freight issues, last mile logistics, decarbonisation of freight
- Road to Zero action plan
- Condition Rating the future of Improvement Plans management of
- Keep up the good work
- Public Transport Infrastructure RCA supporting our PT networks
- Improvement opportunities for the coordination of LTP / RLTP / NLTP.
- A key issue for discussion across the country is the investment in maintenance & operations and renewals of the existing roading network. A well-maintained network is also a safer network.
- When is NZTS going to deliver in South Island outside of Christchurch and Kiakaria [Kaikoura]?
- The NZTA annual plan process and RAPP tour seem to have little value. We spend significant time and funds on preparing the plan and telling the story, but they skip to last page and already know the outcome.
- Less of REG.
- Road to zero, traffic standards.
- Shifting heavy transport from road to rail, except for local distribution; National uniform standards for improved TMP requirements for cattle crossings; Review and rationalise health and safety regulations and TMPs to reduce and curb the huge rise in costs; Review the road rules to add a rule "first come, first go" to use at intersections when traffic lights don't work.
- I am a Mayor and believe this Forum is a technical group and should be devoid of any political Input. It should for Technical Management Personnel only.
- Coordinated forward works coordinated procurement approaches (panels, etc).
